

Call for Nominations

FASP Executive Board Members advocate for the profession of school psychology by representing all FASP members in areas such as professional development, best practices, ethics, private practice, school based services, legislation, and member outreach.

Benefits of being on the FASP Executive Board: You will be a leader in your field, be on the cusp of all of the latest and greatest news/information in school psychology, be a voice for our members and be a key decision maker for FASP policies and procedures

Requirements: Nominees must be a current FASP member (verifiable) and be willing to serve the length of time denoted after each open position. The FASP Executive Board typically meets 3-4 times per year (inclusive of Summer Institute and Annual Conference) and board members are expected to attend these meetings (typically Friday afternoon through Saturday afternoon). Accommodations and travel are reimbursed (within reason).

FASP is now accepting nominations for the following positions:

President Elect- The President-Elect functions as the President in the latter's absence or incapacity, exercises general supervision over the Annual Conference, and becomes President at the close of term of office as President-Elect.

Treasurer Elect- The position of Treasurer is a two-year term coinciding with two of FASP's fiscal years. The Treasurer-Elect works with the current Treasurer to learn the duties and responsibilities of the office before assuming the office on February 1 of the following year. As the chief financial officer of FASP, the Treasurer is responsible for overseeing the custody of all FASP funds, keeping records of all receipts and expenditures, providing an annual review, monitoring FASP's annual budget, and other related duties.

Secretary- The Secretary serves a two-year term. The Secretary is responsible for keeping all the records of FASP and of the Executive Board including taking minutes and motions at Executive Board meetings and annual Business Meeting, and request and compile board member reports for business meetings.

Regional representatives (Listed below with their respective counties): Regional representatives act as a liaison between the membership of their region and the Executive Board. Only members in the respective counties may be nominated for these positions.

Nominations are being accepted for:

Region 1 - Northwest: Bay, Calhoun, Escambia, Franklin, Gadsden, Gulf, Holmes, Jackson, Jefferson, Leon, Liberty, Madison, Okaloosa, Santa Rosa, Taylor, Wakulla, Walton, Washington.

Region 3 - East Central: Brevard, Lake, Orange, Osceola, Seminole, Sumter.

Region 5 - Southwest: Charlotte, Collier, Desoto, Glades, Hardee, Hendry, Highlands, Lee, Manatee, Sarasota.

Region 7 - South: Dade, Monroe.

All Members may nominate for the position of President Elect, Treasurer Elect, and Secretary.

Members may nominate for the Regional Representative Position that represents their county.

Members can nominate other members or can nominate themselves for positions. Nominees will be contacted individually to accept/decline the nomination. If the nomination is accepted, a brief biographical statement will be due to Past President Brad Underhill by April 30, 2010. Elections will be held in May 2010 and results will be available in June 2010.
