## **General Conference Information**

#### When and where is the conference taking place?

The 2025 FASP Annual Conference will be held October 14–18 at the Innisbrook Golf Resort in Palm Harbor, Florida.

#### What is the theme of this year's conference?

This year's theme is **IGNITE** the Future of School Psychology — a call to energize our profession and inspire innovation.

### Registration & Access

#### What does registration for Wednesday and Thursday include?

Your registration includes:

- Access to all selected sessions
- CE/CPD credits for eligible presentations
- Access to conference materials via the FASP Conference App

#### Is there a virtual option available?

FASP offers a Virtual+ registration option exclusively for attendees who register for and attend the in-person conference. Virtual+ includes access to 14 recorded, 3-hour sessions by featured speakers, available for on-demand learning for one month, beginning a few days after the conference concludes at Innisbrook.

Please note: There is no Virtual-Only option. You must attend the conference in person to access the Virtual+ recordings. Please note that credit eligibility depends on your licensure requirements.

#### Are there registration discounts for volunteers?

#### Are printed materials provided?

### How do I book my hotel room?

#### What is the room rate at Innisbrook?

\$149 per night (single/double occupancy) plus a \$40 resort fee and applicable taxes. Additional adult occupants are subject to a \$20 charge per night plus taxes.

#### Are there restaurants nearby?

There is limited access to restaurants outside of the resort. Please plan accordingly. The resort has on-site dining options.

#### Is there transportation within the resort?

Yes. The hotel offers on-property golf cart transportation for registered guests. You must call the front desk to request a golf cart. Please plan ahead to allow wait time.

#### Meals & Events

#### What meals are included?

### **Continuing Education (CEs and CPDs)**

#### How will CE and CPD credits be tracked?

CEs will be tracked using paper sign-in and sign-out sheets. Attendees are responsible for signing in and out at each eligible session to receive credit. FASP follows all requirements for CE and CPD providership and will report your sessions to CE Broker when applicable.

#### Who is eligible to receive CE and CPD credits?

FASP is approved by Florida Department of Health's Division of Medical Quality Assurance (MQA) to offer CEs toward licensure for continuing education. CEs are available for School Psychologists and Psychologists (50-693); Mental Health Counselors, Marriage and Family Therapists and Clinical Social Workers (BAP-174). FASP is a NASP approved provider to offer CPDs (#1029). There will be strict adherence to virtual attendance procedures to allow us to continue to offer CEs and CPDs.

**NOTE**: FASP cannot offer in-service points for renewal of Florida certification for Certified School Psychologists or other educational specialists holding a professional certificate issued by the Florida Department of Education (FDOE). However, many school districts have procedures to obtain in-service points toward renewal of FDOE certificates under their master in-service component. Participants should check with their school district's certification officer to verify eliqibility and procedures to earn in-service points for this workshop.

- Florida Licensed PSYCHOLOGISTS (PY# or LPY#) MUST attend "LIVE" sessions to earn CEs.
- Licensed SCHOOL PSYCHOLOGISTS (SS#) may receive CEs for live or on-demand sessions.

#### Will you report my sessions to CE Broker?

Yes. For eligible professionals, FASP will report your credits to CE Broker once attendance and evaluation requirements have been verified.

#### Will I receive a certificate?

Yes. Certificates will be available on-site when you sign-out. If attending Virtual+ on-demand, you will receive electronic certificates if you complete attendance verification checks and once you complete an electronic evaluation form.

#### Any additional requirements I should know about?

Due to state and national requirements, there will be strict adherence to attendance tracking for both in-person and virtual components. This ensures that FASP may continue offering high-quality, board-approved CEs and CPDs in the future.
